



# **HEDIS Category II**

## Coding Bulletin 2025

HEDIS® is a widely used set of performance measures developed and maintained by NCQA. These are used to drive improvement efforts surrounding best practices.

Reduce the number of medical records we request from you during the HEDIS medical record review season (January to May each year) by adding specific CPT® Cat II codes to your claims. These codes will help us identify additional information about the visit and improve the accuracy of reporting HEDIS quality measures.

### Prenatal and Postpartum Care (PPC)

Description	Codes
Stand-alone prenatal visits	<b>0500F:</b> Initial prenatal care visit (report at first prenatal encounter with healthcare professional providing obstetrical care. Report also the date of visit and, in a separate field, the date of the last menstrual period [LMP]) (Prenatal) <i>or</i> <b>0501F:</b> Prenatal flow sheet documented in the medical record by first prenatal visit (documentation includes, at minimum, blood pressure, weight, urine protein, uterine size, fetal heart tones, and estimated date of delivery). Report also: date of visit and, in a separate field, the date of the last menstrual period (LMP) ( <b>Note:</b> If reporting 0501F prenatal flow sheet, it is not necessary to report 0500F initial prenatal care visit) (Prenatal) <b>0502F:</b> Subsequent prenatal care visit (Prenatal). Excludes: patients who are seen for a condition unrelated to pregnancy or prenatal care (for example, an upper respiratory infection; patients seen for consultation only, not for continuing care).
Postpartum care visit	<b>0503F:</b> Make sure the visit is on or between seven and 84 days of delivery.

Eye exam with evidence of retinopathy	<b>2022F:</b> Dilated retinal eye exam with interpretation by an ophthalmologist or optometrist documented and reviewed; with evidence of retinopathy (DM) <b>2024F:</b> Seven standard field stereoscopic retinal photos with interpretation by an ophthalmologist or optometrist documented and reviewed; with evidence of retinopathy (DM) <b>2026F:</b> Eye imaging validated to match diagnosis from seven standard field stereoscopic retinal photo results documented and reviewed; with evidence of retinopathy (DM)
Eye exam without evidence of retinopathy	<b>2023F:</b> Dilated retinal eye exam with interpretation by an ophthalmologist or optometrist documented and reviewed; without evidence of retinopathy (DM) <b>2025F:</b> Seven standard field stereoscopic retinal photos with interpretation by an ophthalmologist or optometrist documented and reviewed; without evidence of retinopathy (DM) <b>2033F:</b> Eye imaging validated to match diagnosis from seven standard field stereoscopic retinal photos results documented and reviewed; without evidence of retinopathy (DM)

#### Notes

- Presence or absence of retinopathy must be represented by a CPT II code on claims.
- When the exam is performed by the PCP and read by an eye care provider, the claim must be billed with the appropriate CPT Category II code (with no modifier) to meet the HEDIS technical specifications indicating the services were performed by a qualified vision Provider.
